Explanatory Statement, pursuant to Section 102(1) of the Companies Act, 2013 in respect of the business above:

ITEM NO.1

The amendment to relevant clauses of Articles of Association of the Institute was felt necessary from time to time in view of the fact that the same were designed and drafted almost 12 years ago and substantial changes in the law governing the Institute has since taken place considering the various regulation issued by IRDAI, amendment to Insurance Act,1938 (Including amendment Act of 2015), repeal of Companies Act,1956 and evolvement of Companies Act,2013 to name a few, not withstanding several past attempts to carry out certain changes which did not find favor with the regulatory authorities. Accordingly, in view to bring out relevant and more important amendments to the Articles of Association as also to incorporate few significant new articles including clarifying amendment to some, approval of the members is being sought through this resolution to give effect to the modified Articles of Association. Your directors have secured an in principle approval from IRDAI in terms of Clause VI of the Memorandum of Association vide their letter Dt.07.03.2017& 15.03.2017.

ITEM NO. 2

The members had sought clarifications on annual accounts for the year 2015-16 on certain matters at their Annual General Meeting held on 27.12.2016 at Hyderabad. Board intends to clarify on all such matters as posed and accordingly in confirmation thereof seeks to pass the proposed resolution.

ITEM NO.3

Ratification of appointment of Statutory Auditors was kept in abeyance by members at their AGM held on 27.12.2016 to an EGM to be called wherein management was supposed to clarify on certain issues related to annual accounts for the year 2015-16. This despite the fact that the members had raised such issues based on the qualified report of the auditors. Your Board recommends ratification of appointment of the Statutory Auditors as proposed in the resolution.
