PROPOSED RULES & REGULATIONS

1-NAME OF THE FUND : IIISLA BENEVOLENT FUND

2-ADDRESS: Administrative office of IIISLA situated at Flat No.315, Paras Chambers , Door No.3-5-890 Himayath Nagar, Hyderabad or any other place as authorized by the central council of IIISLA.

3-DURATION OF THE FUND

The fund shall come into existence on 01^{st} April,2016 and shall last till the existence of IIISLA or as decided by central council of IIISLA.

4-ELIGIBILITY FOR MEMBERSHIP:

- A)-All valid IIISLA Members attaining the age of 70 years as on cutoff date for membership of fund i.e. 31- 05-2016 subject to an application on prescribed format as provided by the central council of IIISLA.
- B)-The membership of fund is mandatory for all IIISLA members.

5-FORMATION OF FUND:

- A)- To form a corpus fund, each member shall contribute one time membership/Admission fee of Rs. 2,000.00/-(Rs. Two Thousand only).
- B)-Corpus fund will be utilized only in any exigency.
- C)- Annual subscription fee shall be Rs. 1000.00(Rs .One Thousand only) which will be payable along with the annual IIISLA membership fee.
- D)- Mode of payment will be through cheque / Demand Draft / NEFT or RTGS or as decided by IIISLA council time to time. In no case cash is accepted.

6-AIMS & OBJECTS OF THE FUND:

- A)-To extend succor to the legal dependents/nominee of the members in case of natural death & listed critical illness of the members up to an age of 70 years as per birth certificate / high School certificate or any other valid and legal age proof. Natural death will not be covered thereafter.
- B)-Members crossing 70 years of age will continue to be member of the fund with limited benefit for the treatment of the following specific critical diseases;

- I)- Lever Cirrhosis
- II)-Cancer
- III)-Kidney transplant
- IV)-Liver Transplant
- V)-Heart Bypass surgery

Or any other critical ailment as suggested by the executive body of fund and approved in general body meeting of IIISLA .

C)-Accidental death and or permanent/partial/total disablement or benefits which are already covered under personal accident policy taken by IIISLA will not be covered under this fund.

7-MANAGEMENT OF THE FUND:

- A)-The Corpus fund and annual subscription for "IIISLA Benevolent fund" so collected will be deposited in a separate bank account opened for the purpose in any nationalized bank with the title "IIISLA BENEVOLENT FUND."
- B)- Fund to be invested in fixed deposits in a scheduled nationalized bank.
- C)-There shall not be any cash transaction in "IIISLA BENEVOLENT FUND" bank account.
- D)-Fund management expenses shall be borne by IIISLA Council.
- E)-The accounts will be displayed on IIISLA web portal under heading "IIISLA BENEVOLENT FUND" from time to time.
- F)-The accounts will be audited by external auditor other than IIISLA external auditor. The annual audit report will be displayed on IIISLA web portal.

8-GENERAL BODY OF THE FUND:

All members forming the "IIISLA Benevolent Fund" shall constitute General Body. To minimize expenses in the fund any General Body Meeting of IIISLA will hold good for the General Body Meeting of IIISLA Benevolent Fund

9-ADMINISTRATION OF THE FUND:

- A)-Administrative body comprising of following:-
 - 1. PRESIDENT
 - 2. SECRETARY
 - 3. TREASURER
 - 4. EXECUTIVE MEMBER
 - 5. EXECUTIVE MEMBER
 - 6. EXECUTIVE MEMBER
 - 7. EXECUTIVE MEMBER

B)-The administrative body shall comprise of two present & valid council members and one IIISLA member for the post of President, Secretary and Treasurer as nominated by IIISLA central council. Four executive members will be nominated from each zone.

C)-The tenure of the administrative body will be for one year (365 Days) from the date of its formation.

10-AMENDMENT TO RULES:

No amendment could be done in basic framework until unless recommended by at least 30% of the valid members either in person or written request routed through Chapter, Zone and Central Council. Addition and deletion in critical deceases or beneficiary amount may be amended in general body meeting of IIISLA.

11-DISPUTES AND ANCILLARY MATTERS:

All disputes with regard to administration of the FUND shall be decided by the General Body by majority vote, and shall be final and binding upon all concerned.

12-BENEFICIARY AMOUNT:

A)-In case of natural death the legal heir/nominee will get Rs. 5,00,000.00 (Rs. Five Lac only)

B)-and critical disease as defined above maximum Rs. 2,00,000.00(Rs. Two Lac only) subject to as decided by the executive body of Fund.

13-DONATIONS TO FUND

Public donations are accepted only by cheque or Demand draft and its receipt will be issued by administrative office only.

14)-DISSOLUTION OF FUND

In case the fund gets dissolved for any reasons the entire fund amount will be evenly distributed to its valid member as on date.
