
Project Overview

• Key Objectives:

- Automated Allocation: Intelligent assignment of survey work to surveyors based on predefined criteria.
- **Transparency**: Enhanced visibility into claim assignments and real-time status tracking.
- Comprehensive Reporting: Summary reports for all stakeholders.
- This solution aims to streamline the survey assignment process, improve efficiency, and enhance accountability across the ecosystem.

- 1. Claims Assignment to Surveyor
- 2. Not-Eligible for ASAP Assignment

Allocation Logic

Allocation Logic will be on a real-time basis. Based on the following parameters:

- Serviceable Area of the Surveyor and Claim location.
- Skillset: Line of Business
- Priority
 - Open Jobs (Claims which are not completed from the Insurance End)
 - Open Claim Amount: Summation of Open Claim amount in his bucket
 - Performance (Collected from the Insurance company while job completion)





Surveyor Flow




Insurance Company Admin Flow




GIC Admin Flow


