ROAD: The main Highways connecting Katni are:

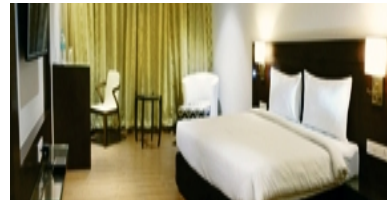
