As you all know that now the Gazette notification 2015 is notified by the Authority. Although the content of these regulations are not in complete favor of Independent Surveyor but still there are many grey areas to be utilized for betterment of Profession.

Although Our IISLA Council have tried level best to amend the propose exposure draft & I am thankful to my colleague friends who had sent various representation to IRDAI for exposure draft but as now clearly understood that IRDAI is working under the pressure of Private Insurer & IRDAI has given preference to Interest of Private Insurer against **interest of Policy Holders** for which now again we have made strong representation to MOF & accordingly MOF has assured to look into the matter.

Dear Friends, the efforts of IISLA Council in terms of Mandatory Membership, Categorization Issue, Insurance Act 2015 with unconditional support of our member are in front of members & of Course although these were never be appreciated **by the Non Practicing Surveyor/self styled leader having no base in local area/profession** & this is their problem & our Council have to work only for professional surveyors whose living hood depends upon our noble profession.

Now a days there are lot of hue & cry among members due to half bakes information flared by few ones who have personally no interest in development of our noble profession & in routine always flare a wrong message about the IISLA Council Team who worked very hard for the up gradation of profession. We understand that Now Gazette Regulation 2015 has been flashed by the Authority & there are lot of regulations imposed by Authority even after opposition in subject matter, but Still we have not to be harassed & move further for up gradation of our profession.

Our aim of mandatory membership has already implemented in public sector as per order of MOF & now Gazette notification/Insurance Act 2015 has also in front of you according to which every SLA holder must having Membership of IISLA which is a Milestone in history of our Profession & every SLA has now follow the code of Conduct/Ethics of IISLA as laid down in our MOA & AOA.

Regarding Membership Issue I on behalf of Council assure that As per our AOA/MOA our membership is restricted to Independent Surveyor only & this words Independent which is blessing of our Great Leader Late Sh.M.J.Dhruva will never be removed from our AOA/MOA,so member are further advised not to be panic by wrong message being flared by Frustrated persons.

We are in continuous process of rectifying our membership list by removing employee surveyor as per feedback received from Chapters/Zones & all of you are further requested to inform about same to admin office for which We have already flashed a Notice on our website.

Moreover regarding Qualification Issue, it is to be clarified that Members categorized before 2001 by the categorization committee will need not to be worries by this regulations.

So I appeal on behalf of IISLA Council that plz don't bother for half cooked news & read out the Gazette Notification 2015 & sent same to all concerned whether Insurer/Garages/Insured **with a clear**

message that now every surveyor has to conduct survey himself as per Code of Conduct.ChapterVI of Regulation.

Moreover as per notification regarding Trainee Applicants Chapter-VII,it is clearly mentioned as a **Trainee Surveyor Not accept/Perform/Undertaking/any survey works & not issue any survey report without holding a valid licence issued by the Authority to act as surveyor & loss assessor.** So all of you are requested to plz understand this regulation according to which Trainee Surveyor of any Insurer/Members will not carried any survey job & violation of this regulation should immediately be directly forwarded to authority without any delay.with a copy to admin@iiisla.co.in.

Regarding Corporate Licence it is clearly that **Licence Surveyors who are working as Employee of the Company/Firm shall undertake survey job only of that company/firm with whom he/she is employed with.** The employee shall undertake survey jobs only in those department & level of membership allotted to him/her under his individual Licence. So plz understand these regulations which are not totally against our profession but only concept is to understand same & implement on each Members of IIISLA without any further delay.

Dear Colleagues Friends, these are few point on behalf of which We have already started initiating against Inhouse claim Analyst ,so called self Styled SLA. Now I appeal all of you specially **Motor Surveyors of my Young Brigade,that plz start this move in your area after taking in confidence to Our Seniors Surveyors** & only arrange documentary evidence of unlicensed person in name of Trainee Surveyor/Assiatant for which he has perform survey work on behalf of Insurer/SLA & avoid Man Handling.& further sent same to Council & IRDAI official directly.

All of you are requested not to involve in any activities which is against the Code of Conduct of IIISLA & perform their survey job on personnel level without taking the services of any assistant for undertaking survey job.

I assure you that IIISLA council is always there for the betterment of Members & of firm believe that when with unconditional support of our members we have maintained 64UM & now being part of Insurance Act 2015,we will certainly move ahead for the growth of Profession.
