- 2.Regulation 2019 issue pursued with MOF, in 4 CMDs meeting at Delhi with GIPSA and MOF, GI Council .Meetings with ministeres Hon Anurag Thakur , Hon Nirmala Sitaraman [MOF] and presenting the issue of regulation 2019 result is the regulation not yet gazetted / implemented
3. Organized meeting in Nov.2019 of Sr surveyors in Delhi regarding issue of regulation 2019 .
- 4.Met with other members of IAC to convince our stand regarding Proposed Regulation 2019,
5. Took up SMP issues of OIC with CMD and top officials.
- 6.Survey fees revision proposal submitted to GIPSA / GIC 10th Dec 2019 in presence of All CMD s of PSUs
[this has happened for the first time in the history of IIISLA that FOUR CMDs of PSUs met with IIISLA in a single event]
- 7.Shifting of HO premises to new location on 15th Dec 2019
- 8.Digitilazation of all documents at HO.
9. First time Nominee director [IIISLA] from Ministry of Finance attended the Board meeting at Hyderabad our HO place [previously board has to go to Delhi for such meeting.]
- 10.we have submitted our response to the proposals of IRDA to amend 64 UM to MOF.
11. There was accumulated pendency of membership applications @500+ before we came ,which were disposed off and as of now there is no pendency regarding membership applications.
