Friends, Regarding qualification issue under the surveyor regulations, It is to inform you that the matter is already under consideration with the Authorities & same was discussed with Authorities on Feb 12th, 2016 regarding difficulty to comply with present requirement of acquisition of prescribed qualification under surveyor regulations by the existing surveyors, (who don't have such qualification) within the transitory period of 3 years as per regulations. Authorities also noted the requirements of attendance of full time technical course by such surveyors will be difficult to comply. So it is decided that a refresher Course/Workshop may be organized by Our own Esteem Institute at various places with duration of 25 Hours (overall) covering the areas of technical qualifications. It was also

decided that the surveyors who don't hold the required qualifications but completed such course, can be considered for renewal of license after the transitory period.

So it is advised to all members not to panic on the issue & don't spent your hard earned money & energy in different Court cases , and If at any stage Council feel that Court cases are inevitable, then Council itself will move to court in supports of members.

All of you are further requested to trust on council & give us some time to meet your expectations.
