REVISED NOTICE FOR OUTSTANDING SUBSCRIPTION DUES

Please refer to the earlier circular **Ref: Subscription Dues/15-16** dated 18.04.2015, 30.04.2015 and 20.05.2015 uploaded on the IIISLA website under IIISLA Circulars, on the payment of subscription dues for the current year including all the subscription dues of the Previous years.

Attention of members is invited to Section 14(1) iii of the Articles of Association, which reads as follows:

Quote

14(1) The Council may remove from the Register the name of the member of the Institute:

iii) who has not paid any prescribed annual membership fee required to be paid by him within stipulated time as per regulation in force ;

Provided that a member, whose name has been removed under this sub-clause, may be readmitted after he deposits the dues with arrears and re-admission charges and such re-admission charges shall be at the discretion of the council and in the prescribed manner.”

Members are hereby notified that they would be required to clear their outstanding annual subscription for the current year account 2014 – 2015, along with and including outstanding subscription for all earlier periods. The dues must be remitted by Demand Draft/At par cheque drawn in the name of the Institute, payable at Hyderabad, to reach the aforesaid Administrative Office of the Institute at Hyderabad by close of business hours of 10th July, 2015.

In case the outstanding subscription dues is not remitted by 10th July, 2015 ; the name of the concerned member will be struck off the Membership Register and their membership of the Institute would be suspended.

Re-admission fees for suspended members would be Rs.1,000/- for the year 2015-16. However, in case of outstanding dues exceeding 3 years subscription as of 10th July, 2015 the member's name would be struck off the Membership Register permanently and the said person would no longer enjoy the membership of the Institute.
